This plan is reviewed and updated annually to ensure that exam contingency planning at Saint Benedict Catholic Voluntary Academy is managed in accordance with current requirements and regulations.

Purpose of the plan

This plan examines potential risks and issues that could cause disruption to the exam process.

By outlining actions/procedures to be invoked in case of disruption it is intended to mitigate the impact these disruptions have on our exam process at Saint Benedict Catholic Voluntary Academy .

Alongside internal processes this plan is informed by the Ofqual Exam system contingency plan: England, Wales and Northern Ireland which provides guidance in the publication, What schools and colleges and other centres should do if exams or other assessments are seriously disrupted and the JCQ Joint Contingency Plan for the Examination System in England, Wales and Northern Ireland.

This plan details how Saint Benedict Catholic Voluntary Academy complies with the JCQ's **General Regulations for Approved Centres** (section 5.3, Centre management) by having in place a written examination contingency plan which covers all aspects of examination administration. This will allow members of the senior leadership team to act immediately in the event of an emergency or staff absence. The examination contingency plan should reinforce procedures in the event of the centre being unavailable for examinations, or on results day, owing to an unforeseen emergency. The potential impact of a cyber-attack should also be considered.

Possible causes of disruption to the exam process

1. Exams officer absence at key points in the exam process (exam cycle)

Criteria for implementation of the plan

Key tasks required in the management and administration of the exam cycle not undertaken including:

Planning

- · annual data collection exercise not undertaken to collate information on qualifications and awarding body specifications being delivered
- · annual exams plan not produced identifying essential key tasks, key dates and deadlines
- sufficient invigilators not recruited

Entries

- · awarding bodies not being informed of early/estimated entries which prompts release of early information required by teaching staff
- · candidates not being entered with awarding bodies for external exams/assessment
- · awarding body entry deadlines missed or late or other penalty fees being incurred

Pre-exams

- · invigilators not trained or updated on changes to instructions for conducting exams
- exam timetabling, rooming allocation; and invigilation schedules not prepared
- · candidates not briefed on exam timetables and awarding body information for candidates
- · confidential exam/assessment materials and candidates' work not stored under required secure conditions
- · internal assessment marks and samples of candidates' work not submitted to awarding bodies/external moderators

Exam time

- · exams/assessments not taken under the conditions prescribed by awarding bodies
- required reports/requests not submitted to awarding bodies during exam/assessment periods, for example very late arrival, suspected malpractice, special consideration
- · candidates' scripts not dispatched as required for marking to awarding bodies

Results and post-results

- · access to examination results affecting the distribution of results to candidates
- the facilitation of post-results services

Other criteria:

Centre actions to mitigate the impact of the disruption listed above

The centre will:

- In the event of EO extended absence, Head to appoint an acting Exams Officer as soon as possible, An Examinations Officer of another school can be requested to provide assistance.
- Data Manager/ Head of IT to assist in tasks which involve SIMS and/or A2C
- Line Manager for Exams to liaise with Data Manager over entries.
- Line Manager for Exams, Curriculum Directors, Data Manager, to liaise over pre-exam administration.
- Line Manager for Exams to ensure exam time issues and results process is understood by acting EO.
- All procedures should be documented.

2. ALS lead/SENCo extended absence at key points in the exam process (exam cycle)

Criteria for implementation of the plan

Key tasks required in the management and administration of the access arrangements process within the exam cycle not undertaken including:

Planning

- · candidates not tested/assessed to identify potential access arrangement requirements
- centre fails to recognise its duties towards disabled candidates as defined under the terms of the Equality Act 2010
- · evidence of need and evidence to support normal way of working not collated

Pre-exams

- · approval for access arrangements not applied for to the awarding body
- centre-delegated arrangements not put in place
- · modified paper requirements not identified in a timely manner to enable ordering to meet external deadline
- · staff (facilitators) providing support to access arrangement candidates not allocated and trained

Exam time

· access arrangement candidate support not arranged for exam rooms

Other criteria:

Centre actions to mitigate the impact of the disruption listed above

The centre will:

- Head to appoint an experienced member of the SEN team as acting SENCo as soon as possible.
- Testing and Assessments continue to be carried out by qualified members of the SEND team.
- Applications for Access Arrangements to be made in conjunction with the Exams Officer.
- · Senior members of the SEND team to be fully up to date with JCQ Regulations for Access Arrangements
- Check documentation with SEND Clerical Support
- Acting SENCo, Line Manager for Exams and Line Manager for SEND to identify any candidates not yet approved by Awarding Bodies and complete as necessary.
- Acting SENCo/Line Manager for SEND to ensure all paperwork/documentation is fully prepared and available for inspection by JCQ.
- Acting SENCo/Line Manager for SEND to oversee any JCQ inspection of Access Arrangements.

3. Teaching staff extended absence at key points in the exam process (exam cycle)

Criteria for implementation of the plan

Key tasks not undertaken including:

- · Early/estimated entry information not provided to the exams officer on time; resulting in pre-release information not being received
- Final entry information not provided to the exams officer on time; resulting in candidates not being entered for exams/assessments or being entered late/late or other penalty fees being charged by awarding bodies
- · Non-examination assessment tasks not set/issued/taken by candidates as scheduled
- Candidates not being informed of centre assessed marks before marks are submitted to the awarding body and therefore not being able to consider appealing internal assessment decisions and requesting a review of the centre's marking
- · Internal assessment marks and candidates' work not provided to meet awarding body submission deadlines

Other criteria:

• No other criteria identified

Centre actions to mitigate the impact of the disruption listed above

The centre will:

- · Adjust the timetable as far as is practicable to ensure subject specialist teachers are teaching examination groups
- · Head to appoint acting CD or subject teacher/specialist supply staff, as required

4. Invigilators - lack of appropriately trained invigilators or invigilator absence

Criteria for implementation of the plan

- · Failure to recruit and train sufficient invigilators to conduct exams
- Invigilator shortage on peak exam days
- Invigilator absence on the day of an exam

Other criteria:

Centre actions to mitigate the impact of the disruption listed above

The centre will:

- · Contact other invigilators on our contact list to bring them into school
- · Use trained agency staff on our contact list
- If possible, reseat examinations to reduce the number of invigilators that are required
- Combine satellite rooms if appropriate for SEND
- · Use appropriate staff as invigilators- following JCQ regulations

5. Exam rooms - lack of appropriate rooms or main venue(s) unavailable at short notice

Criteria for implementation of the plan

- · Exams officer unable to identify sufficient/appropriate rooms during exams timetable planning
- · Insufficient rooms available on peak exam days
- Main exam venues unavailable due to an unexpected incident at exam time

Other criteria:

· Alternative school spaces to be considered in school

Centre actions to mitigate the impact of the disruption listed above

The centre will:

- (where main exam venue(s) unavailable due to an unexpected incident at exam time) where possible, make use of other available rooms within the centre, prioritising candidates whose progression will be severely delayed if they do not take their exam or timetabled assessment when planned
- identify whether the exam or timetabled assessment can be sat at an alternative venue, in agreement with the relevant awarding body
- (where main exam venue(s) unavailable due to an unexpected incident at exam time) where possible, move to alternative venue, prioritising candidates whose progression will be severely delayed if they do not take their exam or timetabled assessment when planned

Alternative venue details:

- Other appropriate schools within the MAT as identified by the Head of Centre
 - · communicate with candidates (and where appropriate, parents/carers) any changes to the exam or assessment timetable or venue
 - · communicate with candidates (and where appropriate, parents/carers) any changes to the exam or assessment timetable or to the venue

Communication details:

• Communication will be sent by all forms of communication; letter, phone calls, email and text to candidates and parents/carers of those affected

- · ensure the secure transportation of question papers or assessment materials to the alternative venue
- (after the exam) consider whether any candidate's ability to take the assessment or demonstrate their level of attainment has been materially affected and, if so, apply for special consideration

Other centre actions:

6. Cyber-attack

Criteria for implementation of the plan

· Where a cyber-attack may compromise any aspect of delivery

Other criteria:

• No other criteria identified

Centre actions to mitigate the impact of the disruption listed above

The centre will:

• Line Manager for Exams, EO and IT to liaise with the Examination Boards as to appropriate action and alternative methods of exam administration.

7. Failure of IT systems

Criteria for implementation of the plan

- MIS/IT system failure at final entry deadline
- MIS/IT system failure during exams preparation
- MIS/IT system failure at results release time

Other criteria:

• No other criteria identified

Centre actions to mitigate the impact of the disruption listed above

The centre will:

- Failure at Entry Deadline Line Manager for Exams to liaise with Data Manager/ Head of IT and Exams Officer to enable a swift resolution to any issues.
- Exams Officer to contact exam boards as quickly as possible to identify alternative route for processing entries (e.g. via exam board secure websites).
- Failure during exams preparation Line Manager for Exams to liaise with the Data Manager/ Head of IT as above. Exams Officer to inform exam boards of ongoing situation
- Failure at results release time Line Manager for Exams to liaise with Data Manager/ Head of IT and Exams Officer to enable a swift resolution to any issues.
- Exams Officer to contact exam boards as quickly as possible to identify alternative route for receiving results (e.g. via exam board secure sites).

8. Emergency evacuation of the exam room (or centre lockdown)

Criteria for implementation of the plan

• Whole centre evacuation (or lockdown) during exam time due to serious incident resulting in exam candidates being unable to start, proceed with or complete their exams

Other criteria:

- Invigilators, Line Manager for Exams, SLT, Head of Sixth Form and Exams Officer to ensure emergency evacuation plan is followed, maintaining the integrity of the exam
- Candidates to be held separately, avoiding contact with other pupils, and ensuring that they do not talk to one another; candidates will be relocated to another of our venues wherever possible
- Exam boards to be advised as appropriate

Lockdown

Centre actions to mitigate the impact of the disruption listed above

The centre will:

- refer to and invoke its (exams) emergency evacuation policy/procedure in line with JCQ's 'Centre emergency evacuation procedure' (or its (exams) lockdown policy)
- · contact the relevant awarding body as soon as possible and follow its instructions
- where accommodation is limited, prioritise candidates whose progression will be severely delayed if they do not take their exam or timetabled assessment when planned
- (after the exam) consider whether any candidate's ability to take the assessment or demonstrate their level of attainment has been materially affected and, if so, apply for special consideration

Other centre actions:

9. Disruption of teaching time in the weeks before an exam - centre closed for an extended period

Criteria for implementation of the plan

• Centre closed or candidates are unable to attend for an extended period during normal teaching or study supported time, interrupting the provision of normal teaching and learning

Other criteria:

• EO to liaise with Line Manager for Exams/ Head of Centre and Awarding Bodies to source alternative.

Centre actions to mitigate the impact of the disruption listed above

The centre will:

- · recognise it remains the responsibility of the centre to prepare students, as usual, for examinations
- facilitate alternative methods of learning
- · communicate with candidates (and where appropriate, parents/carers) information relating to alternative methods of learning

Communication details:

• Communication will be sent by all forms of communication; letter, phone calls, email and text to candidates and parents/carers of those affected.

- take advice offered by the awarding body regarding alternative arrangements for conducting examinations that may be available
- take advice offered by the awarding body on the options for candidates who have not been able to take scheduled examinations
- · advise candidates, where appropriate, of the opportunities to take their exam or assessment at a later date

Other centre actions:

• No other criteria available

10. Candidates at risk of being unable to take examinations - centre remains open

Criteria for implementation of the plan

• Candidates at risk of being unable to attend the examination centre to take examinations as normal

Other criteria:

- Consideration would be given on an individual basis as to why candidates did not attend. Special consideration may be applied for.
- Monitor news agencies on a regular basis to identify potential transportation difficulties.

- Centre to utilise own minibuses to transport candidates to centre.
- Centre to liaise with candidates to identify whether the examinations can be sat at an alternative venue in agreement with the relevant awarding organisations.
- Centres of offer candidates an opportunity to sit any examinations missed at the next available series.
- Centres to apply to awarding bodies for special consideration for candidates where they have met the minimum requirement.
- Latecomers to be permitted to take their examinations as per JCQ regulations.

Centre actions to mitigate the impact of the disruption listed above

The centre will:

- take advice offered by the awarding body on the options for candidates who have not been able to take scheduled examinations
- discuss alternative arrangements with the awarding body if a candidate misses an exam or loses their assessment due to an emergency, or other event, outside of the candidate's control
- identify whether the exam or timetabled assessment can be sat at an alternative venue, in agreement with the relevant awarding body, ensuring the secure transportation of questions papers or assessment materials to the alternative venue
- communicate with candidates (and where appropriate, parents/carers) any changes to the exam or assessment timetable or to the venue

Communication details:

- · Communication will be sent by all forms of communication; letter, phone calls, email and text to candidates and parents/carers of those affected
 - consider whether any candidates' ability to take the assessment or demonstrate their level of attainment has been materially affected and, if so, apply for special consideration

Other centre actions:

11. Centre at risk of being unable to open as normal during the examination period (including in the event of the centre being unavailable for examinations owing to an unforseen emergency)

Criteria for implementation of the plan

· Centre at risk of being unable to open as normal for scheduled examinations

Other criteria:

Centre actions to mitigate the impact of the disruption listed above

The centre will:

- take advice, or follow instructions, from relevant local or national agencies in deciding whether the centre is able to open
- contact the relevant awarding body as soon as possible and follow its instructions
- · discuss alternative arrangements with the awarding body if the exam or assessment cannot take place
- · follow guidance provided by the awarding body on the conduct of examinations in such circumstances
- where accommodation is limited, prioritise candidates whose progression will be severely delayed if they do not take their exam or timetabled assessment when planned
- communicate with candidates (and where appropriate, parents/carers) any changes to the exam or assessment timetable or to the venue

Alternative venue details:

• Alternative school within the Saint Ralph Sherwin MAT if applicable

- Communication will be sent by all forms of communication; letter, phone calls, email and text to candidates and parents/carers of those affected
 - consider whether any candidates' ability to take the assessment or demonstrate their level of attainment has been materially affected and, if so, apply for special consideration

12. Disruption in the distribution of examination papers

• Disruption to the distribution of examination papers to the centre in advance of examinations

- liaise with awarding bodies regarding the provision of electronic access to examination papers via a secure external network and will ensure when copies are received/made these are stored under secure conditions
- follow guidance provided by the awarding body on the conduct of examinations in such circumstances
- understand that as a last resort, and in close collaboration with centres and regulators, awarding organisations will consider scheduling of the examination on an alternative date
- · communicate with candidates (and where appropriate, parents/carers) any changes to the exam or assessment timetable or to the venue

13. Disruption to transporting completed examination scripts

Criteria for implementation of the plan

· Delay in normal collection arrangements for completed examination scripts/assessment evidence

- where examinations are part of the national 'yellow label' service or where awarding bodies arrange collections, contact the relevant awarding bodies for advice and instructions and will not make its own arrangements for transportation unless told to do so by the awarding body
- for any examinations where the centre makes its own collection arrangements, investigate alternative options that comply with the requirements detailed in the JCQ publication 'Instructions for Conducting Examinations'
- · ensure the secure storage of completed examination scripts until collection

Disruption to assessments or exams

In the absence of any instruction from the relevant awarding organisation, you should make sure that any exam or timetabled assessment takes place if it is possible to hold it. This may mean relocating to alternative premises. You should discuss alternative arrangements with your awarding organisation if:

- the exam or assessment cannot take place
- a student misses an exam or loses their assessment due to an emergency, or other event, outside of the student's control

Steps you should take

Exam planning

Review contingency plans well in advance of each exam or assessment series. Consider how, if the contingency plan is invoked, you will comply with the awarding organisation's requirements.

In the event of disruption

- 1. Contact the relevant awarding organisation and follow its instructions.
- 2. Take advice, or follow instructions, from relevant local or national agencies in deciding whether your centre is able to open.
- 3. Identify whether the exam or timetabled assessment can be sat at an alternative venue, in agreement with the relevant awarding organisation, ensuring the secure transportation of questions papers or assessment materials to the alternative venue.
- 4. Where accommodation is limited, prioritise students whose progression will be severely delayed if they do not take their exam or timetabled assessment when planned.
- 5. In the event of an evacuation during an examination please refer to JCQ's 'Centre emergency evacuation procedure' (www.jcq.org.uk/examsoffice/ice---instructions-for-conducting-examinations/).
- 6. Communicate with parents, carers and students any changes to the exam or assessment timetable or to the venue.
- 7. Communicate with any external assessors or relevant third parties regarding any changes to the exam or assessment timetable.

After the exam

1. Consider whether any students' ability to take the assessment or demonstrate their level of attainment has been materially affected and, if so, apply for special consideration.

2. Advise students, where appropriate, of the opportunities to take their exam or assessment at a later date.

3. Ensure that scripts are stored under secure conditions.

4. Return scripts to awarding organisations in line with their instructions. Never make alternative arrangements for the transportation of completed exam scripts, unless told to do so by the awarding organisation.

Steps the awarding organisation should take

Exam planning

1. Establish and maintain, and at all times comply with, an up-to-date, written contingency plan.

2. Ensure that the arrangements in place with centres and other third parties enable them to deliver and award qualifications in accordance with their conditions of recognition.

In the event of disruption

- 1. Take all reasonable steps to mitigate any adverse effect, in relation to their qualifications, arising from any disruption.
- 2. Provide effective guidance to any of their centres delivering qualifications.

3. Ensure that where an assessment must be completed under specified conditions, students complete the assessment under those conditions (other than where any reasonable adjustments or special considerations require alternative conditions).

- 4. Promptly notify the relevant regulators about any event which could have an adverse effect on students, standards or public confidence.
- 5. Coordinate its communications with the relevant regulators where the disruption has an impact on multiple centres or a wide range of learners.

After the exam

Consider any requests for special consideration for affected students. For example, those who may have lost their internally assessed work or whose performance in assessments or exams could have been affected by the disruption.

If any students miss an exam or are disadvantaged by the disruption

If some of the students have been adversely affected by the disruption, you should ask the awarding organisation about applying for special consideration.

Decisions about special consideration, when it is or is not appropriate, is for each awarding organisation to make. Their decisions might be different for different qualifications and for different subjects.

Wider communications

The regulators, Ofqual in England, Qualifications Wales in Wales and CCEA Regulation in Northern Ireland, will share timely and accurate information, as required, with awarding organisations, government departments and other stakeholders.

The Department for Education in England, the Department of Education in Northern Ireland and the Welsh Government will inform the relevant government ministers as soon as it becomes apparent that there will be significant local or national disruption; and ensure that they are kept updated until the matter is resolved.

Awarding organisations will alert the Universities and Colleges Admissions Service (UCAS) and the Central Applications Office (CAO) about any impact of the disruption on their deadlines and liaise regarding student progression to further and higher education.

Awarding organisations will alert relevant professional bodies or employer groups if the impact of disruption particularly affects them.

Widespread national disruption to the taking of examinations or assessments

The governments' view across England, Wales and Northern Ireland is education should continue in 2021 to 2022 with schools remaining open and that examinations and assessments will go ahead in both autumn 2021 and summer 2022.

As education is devolved, in the event of any widespread sustained national disruption to examinations or assessments, national government departments will communicate with regulators, awarding organisations and centres prior to a public announcement. Regulators will provide advice to government departments on implications for exam timetables.

JCQ guidance taken directly from Instructions for Conducting Examinations 2022-2023 (www.jcq.org.uk/exams-office/ice—instructions-for-conductingexaminations/) section 15, Contingency planning

15.1 The qualification regulators, awarding bodies and government departments responsible for education have prepared and agreed information for schools and colleges in the event of examinations being seriously disrupted. This jointly agreed information will ensure consistency of response in the event of major disruption to the examinations system affecting significant numbers of candidates.

15.2 In addition, awarding bodies have their own well-established contingency plans in place to respond to disruptions. It is important that exams officers who are facing disruption liaise directly with the relevant awarding body/bodies.

15.3 Centres should prepare plans for any disruption to examinations as part of their general emergency planning. It is important to ensure that relevant centre staff are familiar with the plan. Consideration should be given as to how these arrangements will be communicated to candidates, parents and staff should disruption to examinations occur.

15.4 In the event that the head of centre decides the centre cannot be opened for scheduled examinations, the relevant awarding body must be informed as soon as possible. Awarding bodies will be able to offer advice regarding the alternative arrangements for conducting examinations that may be available and the options for candidates who have not been able to take scheduled examinations.

15.5 The awarding bodies will designate 'contingency days' for examinations, summer 2023. This is consistent with the qualification regulators' document *Examsystem* contingency plan: England, Wales and Northern Ireland - www.gov.uk/government/publications/exam-system-contingency-plan-england-wales-and-northern-ireland

The designation of 'contingency days' within the common examination timetable is in the event of national or significant local disruption to examinations. It is part of the awarding bodies' standard contingency planning for examinations.

In the event that there is national disruption to a day of examinations in summer 2023, the awarding bodies will liaise with the qualification regulators and government departments to agree the most appropriate option for managing the impact. As a last resort the affected examinations will be rescheduled. Although every effort would be taken to keep the impact to a minimum, it is possible that there could be more than one timetable date affected following the disruption, up to and including the last contingency day. Centres will be alerted if it was agreed to reschedule the examinations and the affected candidates will be expected to make themselves available in such circumstances. The decision regarding the re-scheduling of examinations will always rest with the awarding body. The centre must conduct the examination on the scheduled date unless instructed to do otherwise by the awarding body.

Where candidates choose not to be available for the rescheduled examination(s) for reasons other than those traditionally covered by special consideration, they will not be eligible for enhanced grading arrangements. Centres must therefore ensure candidates and parents are aware of the contingency arrangements so that they may take them into account when making their plans for the summer. However, the awarding bodies will not insist upon candidates being available throughout the entire timetable period as a matter of course.
